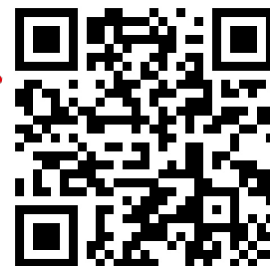
#### **The Solution Already Exists—But They Suppressed It**
